

#### AN OVERVIEW OF THE TRADES AT BOTH GOVT. ITIS.

#### **ENGINEERING TRADES**

**TOOL & DIE MAKER (PRESS TOOLS, JIGS & FIXTURES)** - The course gives complete knowledge on preparation of Tools, Gauges, Fixtures required for Industries. It covers Bending Tool, Compound Tool, Progressive Tool, Draw Tool, Combination Tool etc and CNC Programming. The trainee is made able to manufacture different components for jigs, fixtures and press tools by operating different machines like lathe, drilling, welding, milling, grinding. The trainee can also perform simple repair on machinery. One can take employment with leading Industries and be an entrepreneur as Tool and Die maker (Press Tools, Jig and Fixtures).

**DRAUGHTSMAN** (CIVIL) - The course gives a wide knowledge on construction related manual and CAD drawings, Surveying, Materials, Concrete Technology, and Building Specialization in Construction. One can take gainful employment with construction Industry, Architectural firms/Designers/PWD etc.

**DRAUGHTSMAN** (**MECHANICAL**) - The course gives a wide knowledge on machinery related manual and CAD drawings, Materials, Construction of machine & its materials. One can take gainful employment with manufacturing Industries of Govt. / Private Sectors.

**ELECTRICIAN** - The course has been designed in order to give in-depth practical and theoretical knowledge of conventional and emerging areas related to electrical engineering along with emphasis on electronics like Electrical Circuits, Basic Electronics, Wiring practice, Electrical machines, Measuring technique, Motor Winding practice, Switch Gears, Electrical Sub-Stations, Alternator, Electricity Power Generation, Distribution & Transmission, Domestic Appliances & Lighting and Installation service & maintenance of electrical equipment. On successful completion, one can take employment with Govt./Private sectors as well as self-employment.

ELECTRONICS MECHANIC – The Electronic Mechanic Trade is of two years duration and is in great demand. The course of this Trade broadly covers professional skill and knowledge of Electrical & Electronic Measuring Instruments, Soldering and De-soldering, Power Supply Circuits, Power Electronic Components, Communication Electronics, Digital Storage Oscilloscope, SMPS, UPS, Inverters, Solar Power, Cell Phones, LCD/LED TV, Digital Electronics & Computers and subjects of Engineering drawing, Workshop Calculation & Science and Employability skill. After successful completion of the course of the trade the candidate can get employment in Government/Private Sectors in manufacturing, repairing and servicing field and may be self employed and can also pursue higher General/ technical education.

#### INFORMATION & COMMUNICATION TECHONOLOGY SYSTEM MAINTENANCE -

The role of Information & Communication Technology System Maintenance personnel is to support and maintain computer systems, desktops, and peripherals. This includes installing, diagnosing, repairing, maintaining, and upgrading all hardware and equipment while ensuring optimal workstation performance. The person will also troubleshoot problem areas in a timely and accurate fashion, and provide end user training and assistance where required. Install, maintain and setup network with computers, printers and other peripheral equipment as well as configure broadband equipment.

**MACHINIST GRINDER** - Grinding experience will be in the field of "Surface Grinding and Cylindrical Grinding, Machinist (Grinder) setup and operates variety of machine tools such as Lathe, Surface Grinder Cylindrical Grinder, Tool and Cutter Grinder, Drilling, Lapping and Honing etc. and fits and assembles parts to fabricate or repair machine tools and maintain

industrial machines, applying knowledge of mechanics, shop mathematics, metal properties, layout, and machining procedures. The trainees, admitted after successful completion of their training acquire the skills on various operations in different grinding machines Viz. Centre less grinder, Crankshaft Grinders, Internal & External Grinders, Tool & Cutter grinder apart from basic knowledge on machines. One can take Govt./Private Employments.

MECHANIC MOTOR VEHICLE -The Mechanic motor vehicle is the trade of two years duration in which a candidate is trained by providing him professional skill (Practical Skill), professional knowledge (Theory), along with training of Engg. Drawing, Workshop calculation & science and Employability skill. The candidates are trained from root level of identification of tools to elevated level of performing dismantling, overhauling, repairing, troubleshooting of vehicles of all categories fuelled by Petrol, Diesel and Gases that includes engine, Transmission system, Steering system, Suspension system, Wheels balancing, alignment, Braking system, Electronic control system, Electric components and Air conditioner system. The passout candidates get jobs in automobile industries in manufacturing and servicing sector, vehicle repair workshops and can also be entrepreneurs. The candidates after passing the trade can also pursue further study of general / technical field.

**MECHANIC DIESEL** - The course broadly covers the complete functioning, overhauling of Diesel Engines of vehicles of all categories being fueled by Diesel. Diesel Mechanics also deal with the repair work and maintenance of heavy motor diesel engines such as trucks, buses, public transport vehicles, heavy industrial and construction machinery and equipment and other diesel driven machines such as tractors, cranes, bulldozers etc. The course has a good demand in the Automobile industry thereby giving advantage for either employment or self-employment.

**REFRIGERATION AND AIR CONDITIONING TECHNICIAN** - The course gives an indepth knowledge on Repair & Maintenance of Refrigerators, Centrally Air-conditioning system & Air-conditioners available in the market. On Successful completion, trainees can be absorbed in Railways, Govt./Public Sector under takings apart from self-employment.

**FITTER** - In this trade trainees acquire the skill of using metal cutting, shaping, filing & machinist tools perfectly to make metal parts with accuracy. In this trade knowledge of operating various general machines hydraulic and pneumatic tools used in mechanical industry is also imparted. The demand of Fitter trade trainees is made by Plumbing, Welding, Smithy, Tool Room & Maintenance Department of Industry. Fitter Personnel are able to make precision metal jobs manually as well as on machines. After passing this trade the fitter trainees get jobs in various mechanical industries and also gain self-employment.

MACHINIST – In the 'Machinist Trade' during the course of two years" duration the candidate is trained on subjects professional skill (Trade Practical), professional knowledge (Trade Theory), Engineering Drawing, Workshop calculation & Science and Employability skill. The broad components covered under professional skill subject are training of basic fitting operations, simple to complex machining operations done for manufacturing various jobs on Drilling, Lathe, slotting, Milling, Surface grinding, Cylindrical grinding, Tool and cutter grinding, CNC turning, CNC milling machines and applications of Basic electrical equipments and sensors. After passing out the training programme the candidate can get employment in Railway, defense, Machine tool and Automobile industry etc, or may be self employed and can also pursue further general/technical education.

**TURNER** – The Turner trade is regarded as the backbone of Mechanical Industry. In this trade during the course of two years" duration the candidate is imparted the training of professional skill (Trade Practical), professional knowledge (Trade Theory), Engineering Drawing, Workshop calculation & Science and Employability skill subjects. In professional skill subject the trainees

acquire the skill of basic fitting operations, operating drilling machine, grinding of tools, different simple and complex operations (Turning plain, stepped, grooved, drilled, bored, threaded cylindrical/conical jobs etc.) on conventional lathe Machines and CNC TURNING CENTER. The candidates after passing the Turner trade get jobs in Railway, Defence, Machine Tool & Automobile Industry etc. and may be self-employed. The candidate after passing the trade can also pursue further general /technical education.

**CARPENTER** - The Carpenter trade is of one-year duration and is in great demand in this trade trainee is made able to use all wood working hand tools and machinery to do all those exercises required for making wooden articles of various types like (furniture, doors, almirahs etc.). After this trade, trainees get jobs in private/Govt. sector and can run their own business also.

WELDER - In the 'Welder Trade' during the course of One-year duration the trainees are provided training of subjects professional skill (Trade Practical), professional knowledge (Trade Theory), Engineering Drawing, Workshop calculation &Science and Employability skill. The subject professional skill broadly covers training of Hacksawing, Filing, Marking, Drilling, Arc welding, Gas welding, Gas cutting, Brazing, Spot Welding, GMAW (MIG/MAG welding), GTAW (TIG welding), Welding Simulator, Robotic welding, Pipe welding, Plasma Arc, Abrasive Cutting, Hand Shear Cutting, Power Hacksawing Cutting and Testing of welded joints. There is huge demand in the market for welders in India as well as abroad. Govt. organization like ONGC, NTCP, BHEL, RAILWAY, MARUTI UDYOG LIMITED etc. Candidates after passing the trade can run their own business and have great opportunities for job in private industry in manufacturing as well as in repair units.

**PLUMBER** - This Trade broadly covers installation, repair and maintenance of plumbing fixtures, systems such as water, drain, waste and vent (DWV), low pressure steam, chemical and irrigation. They are able to install specialized systems such as medical gas, process piping, compressed air, water conditioners, fuel piping, sewage and water treatment, and storage and flow equipment. Plumbers may be employed by plumbing/civil work contractors, service companies, and maintenance departments of manufacturing, commercial, health care and educational facilities. They may also be self-employed. Plumbers install piping and equipment in residential, commercial, institutional and industrial buildings and sites.

**INSTRUMENT MECHANIC** - Instrument mechanic trade is a combination of Electrical, Electronics and Basis Computer. This trade is of two years. In today"s modern era without automation there is no progress and instrument mechanic trade is one of the great example to learn overall skills to progress in modern technology. Training is given on following topics like use of Basic Hand Tools, Electrical House Wiring, Use of Electrical Instrument and Calibration, Complete Electronics and Basic Computer, Control of Process like Temperature, Pressure, Flow, Level and Calibration of Instrument, Process control with automation using PLC, DCS, SCADA Software System etc. We have fully equipped Lab, Workshop & Theory Room of this trade to give proper training in ITI to trainees. After this course trainees are eligible for Jobs in Government Sector and in any Industry or can start their own work, shop of being overall skilled person.

MECHANIC AUTO BODY REPAIR - This trade is of one-year duration and was introduced at this Institute with the technical support of Maruti Suzuki India Ltd., under Model ITI Project. Advance technology machines and tools have been installed in this trade. The main work profile of trade is to develop skill in trainee of body denting/ dry denting etc, welding/plastic welding, preparation of body surface for painting, Major damage assessment. In Automobile Industry this trade is in great demand. Passed candidates of this trade can get employment in local and Multi-National organizations/companies.

**MECHANIC AUTO BODY PAINTING** - This trade is of one-year duration was introduced at this Institute with the technical support of Maruti Suzuki India Ltd., under Model ITI Project. Very Advance World Class painting machines and tools and equipments have been installed in

this trade including ultra paint booth, paint mixing machine, roughness testing machine etc. The main work profile of trade is to develop skill in trainee of body Painting/Dry Sending, Primer Application, Paint Application, Paint Mixing and Plastic Painting. In Automobile Industry trained ITI pass painter are in great demand. Passed candidates of this trade are in great demand in Automobile industry and thus can get employment in local and Multi-National organizations/companies.

#### **NON-ENGINEERING TRADES**

MARKETING EXECUTIVE – This is one of the new trades introduced in response to the changing Job Scenario and successfully placing students for the last 4 years in different industries i.e., Retail, IT, Banking, FMCG, FMCD, Education & Hospitality etc. In this course, trainees are prepared for the Job Profiles like Relationship Officer, Retail Store Sales Executive, Front Office Executive, Data Entry & Computer Operator and Customer Care Executive etc. The course sharpens the skills of a trainee in Basic Computer & Internet Applications, MS Office, Written and Spoken English, Social & Formal Etiquettes, Personality Development and Business Communication. We also provide an in-depth theoretical and practical knowledge about the Marketing Concepts like 4 P"s (Product, Price, Place, Promotion), Consumer Behavior, Market Segmentation, Negotiation, Visual Merchandising, Market Intelligence and CRM. Industrial Training, Case Study, Role Play, Group Discussion, Field Visit and Expert Lecture etc. are the widely used Methodologies for Teaching during the entire course. Marketing Executive is truly one-of-a-kind and wonderful choice for those who are looking for a program that offers industry exposure and job opportunities for a good start in their career.

FINANCE EXECUTIVE – In this trade the students are groomed as per the requirements of current employment opportunities by giving practical and theoretical knowledge of computers (MS Word, MS Excel, MS PowerPoint, Internet, Social Media, E-mailing and Searching techniques), Basic Entrepreneur Skills, Quality Parameters, Expert Lectures, Industrial Visits, Case studies and Role plays, imparts knowledge about Banking Policies and Practices, Practical exposure to Banking Procedures, Opening and Operating accounts by visiting the banks, Mobilizing Deposits, Lending and Investment Banking, Role of RBI, Corporate Governance, Mutual Funds, Net Asset Value, Depositories, Derivatives and Stock Market Functioning. The syllabus also includes NCFM Preparatory Modules relating to Derivatives, Depositories, Mutual Funds and Capital Market. They will identify different type of cybercrimes now days and will be able to secure information from Internet by using cyber security concept. The trainees will be able to use cloud for their projects. They will comprehend the basic programming techniques and can create algorithms and flow charts. Trainees will create basic static webpage using HTML. The trainee learns scripting language i.e. JavaScript and will develop dynamic webpage They will be able to develop programmes using Python/Java as an Elective Module.

**SEWING TECHNOLOGY** - This Trade broadly covers knowledge on stitching garments of male, Female & children both Indian & Western designs. After doing this course one can join industry as Tailor in general and will progress further as master Tailor, Supervisor and can rise upto the level of Manager, can become Entrepreneur, can join apprenticeship programs in different types of Industries leading to National Apprenticeship certificate.

**COSMETOLOGY** - This course broadly covers the basic knowledge of anatomy, physiology and dietetics in relation to beauty, hair dressing and effects of cosmetics on human body. On successful completion trainees become capable to work as beautician, hair dresser, makeup artist, manicurist, pedicurist, hair stylist, slimming assistant, hair colorist and a yoga expert and can work at various beauty salons and hotels. They can open their own beauty salons or practice as beauty consultants.

**RESERVATION OF SEATS IN ADMISSION:** 85% seats of the total sanctioned intake of the institute will be filled up from amongst the Candidates who have passed their qualifying examination from School/College recognized by Chandigarh Administration and situated in the Union Territory, Chandigarh as a regular student of the said School/College. (A certificate from the head of School/College to this effect must be attached). CRITERIA FOR PERSONS WITH DISABILITY: For DIVYANG (Person with Disability) Category, the total 4% reservation has been further sub-divided into Groups A,B,C,D & E disabilities for the selected list of the eligible trades against each group as mentioned in Letter MSDE-19/02/2018-CD (pt) dated July 2019 02 https://dgt.gov.in/sites/default/files/Trade\_eligibility\_under\_RPWD\_Act\_2016.pdf. Under this category, the eligible candidates will furnish a medical certificate issued by the Principal Medical officer/ Civil Surgeon of Chandigarh or the concerned district clearly indicating percentage and type of disability, name of the disease causing handicap, whether handicap is temporary or permanent, whether handicap is progressive or non-progressive. The Trainees having temporary handicap would not be considered against the reserved seats for person with disability. Where the certificates are issued by any authority other than the Principal Medical Officer of Chandigarh and the candidate"s turn comes for admission against reserved seat for person with disability, the concerned head of institution shall refer the candidates to the Principal Medical Officer, Chandigarh and shall admit the candidate only after confirmation from the P.M.O. Chandigarh.

#### 5. CRITERIA FOR CHILDREN/GRAND CHILDREN OF FREEDOM FIGHTER:

2 % seats in each pool would be filled from the children and grandchildren of freedom fighters.

#### Note:

- (i) A freedom fighter is a person who has either been granted freedom fighter pension by the Chandigarh Administration or been awarded Tamar Petra for his political sufferings. No person other than the above mentioned persons will be considered as freedom fighters for the purpose of reservation in admission. The requisite certificate will be issued by the Deputy Commissioner, Chandigarh and the certificate issued by any other authority will not make the children and grandchildren of the freedom fighter eligible for seeking admission in the institutions of U.T. Chandigarh. The certificate issued by the Deputy Commissioner in Chandigarh will be taken into consideration irrespective of the form in which it is issued, if the meaning otherwise is clear.
- (ii) Grand Children means son's son/daughter or daughter's son/daughter.
- (iii) The certificate of the candidates who apply under this category from the Chandigarh should be verified by the Deputy Commissioner, U.T. Chandigarh. The outside candidates who

apply against this quota will have to submit their freedom fighter certificate from their concerned Deputy Commissioner of the state.

#### 6. CRITERIA FOR SPORTS PERSON:

2% Seats in each pool would be filled from the sports quota. Application seeking admissionagainst sports quota must submit Gradation Certificate from Director of Sports.

#### 7. CRITERIA FOR WOMEN:

30% seats for women candidates are reserved based on the general reservation policy of U.T, Chandigarh.

#### 8. CRITERIA FOR SCHEDULED TRIBE (ST):

5% of the seats in General Pool are reserved for Scheduled Tribes candidates for all over India who have ST certificates issued in the candidate's name only from the competent authority.

#### 9. CRITERIA FOR ECONOMICALLY WEAKER SECTION (EWS):

10% of seats from amongst the total seats are reserved for Economically Weaker Sections (EWS). They will get Full tuition fee waiver benefit in order of their merit. The candidates seeking admission under this quota will have to submit income certificate based on the economic index and issued by competent authority as mentioned in the table given below.

#### **CONCESSION/FACILITIES:**

- 1. Stipend @ Rs. 100 PM will be paid to all the trainees as per their attendance
- **2.** Merit scholarship of Rs. 125 per month to 4% trainees will also be awarded on the basis of result of internal examination which will be conducted after three months training.
- **3.** No Tuition fee will be charged from SC/ST & Persons with disability, even if he/she takes admission against any other category.
- **4.** Every trainee will give his/her **AADHAAR LINKED BANK ACCOUNT NUMBER** along with IFSC Code immediately after the admission for disbursal of funds i.e. Stipend/Scholarship etc.

#### **TUITION FEE WAIVER SCHEME:**

All the SC/ST/Person with Disability/ EWS candidates are exempted from deposition of tuition fee.

#### **GENERAL NOTES**

If the requisite numbers of candidates of the reserved seats in U.T. Pool are not available, the seats will be thrown open to the candidates belonging to general category of the said pool and similarly in general pool also.

The student who has applied in one or more than one reserved category is to be considered in General Category first in order of his/her merit and then be given chance in other categories.

**N.C.C.** and Games: The interested trainees can take part in NCC (subject to availability) and Games. Facilities for certain numbers of games exist at present and interested trainees can take part in one or more of the items of which facilities are available.

**Library and Reading Room:** There is a library containing Technical Books which can be used for reference by the Trainees

Working Hours: The trainees will undergo training work for Forty (40) hours per week as per the latest trade syllabus issued by DGT, New Delhi.

The timings are as follows:

From 9:30 AM to 5:30 PM with half an hour lunch break from 1:30PM. To 2:00 PM. All Saturday and Sunday will be observed as holidays.

**Holiday:** The Institute will observe all the gazetted and two restricted holidays during the calendar year as declared by the Chandigarh Administration Chandigarh from time to time. However, two holidays will be at the discretion of the Principal of the Institution which shall be granted as and when the occasion arises.

**Attendance and Leave:** The minimum compulsory attendance for the trainees in regard of their eligibility for the final test is 80 percent of the actual number of working days. The shortage of attendance below 80 percent but not below 75 per cent shall be condoned by the Principal; in exceptional cases provided that the trainee has not missed the essential training and the absence was due to unavoidable circumstances reasons beyond his/her control.

**Note:-**If the trainee absents himself for more than the half the number of days i.e. 50% attendance, for whatever reasons his name will automatically struck off from the institute.

Leave.

In addition to holiday, casual leave upto the limit of 12 days during 1 year course and 24 days during the 2 years course will be admissible to trainees subject to maximum 10 days at any one time. If trainee is stipend holder he will continue to draw stipend at the full rate during such leave.

**Medical Leave** 

Besides above trainees will be granted medical leave upto 15 days in a year; leave for further period not exceeding 3 Weeks in continuation or in addition to 15 days absence will be granted on producing the Medical certificate from Medical Officer or a Registered Medical Practitioner.

#### **Special Leave**

Extraordinary leave will be allowed to the trainee upto 15 days. Stipend will not be admissible during such leave. In case, overstay Leave the name of the trainee will be struck off from the rolls and treated as absconder.

**Absconder:** A trainee who absents himself from Training Institute/Centre for 10 Consecutive days without permission and without informing the Principal will be treated as an absconder and his/her name will be struck off from the rolls with effect from the 1<sup>st</sup> day of his absence. However, readmission can be given at the discretion of the Principal with readmission fee of Rs.200/-. No attendance and other benefit will be given on account of re-admission.

**Study Tour:** For the purpose of obtaining an idea of the actual working conditions, the trainees nearing completion of their training will be sent to nearby Industrial Workshops.

**Medical Examination:** The trainees seeking admission in any regular course, in any Branch or in the hostel are required to obtain Medical Certificate from a MBBS Doctor, as required under Training Manual of DGE&T, Govt. of India, New Delhi and submit the same on the date of finalization of their admission at the concerned institute.

**Final Trade Test:** A trainee has to undergo a CBT and Practical examination which is being conducted by the Directorate General of Training (DGT), New Delhi. The certificate issued to him will be National/State level certificate. The examination question papers supplied by the DGT will probably be in both the language (viz. English and Hindi). The examinee can reply in English or Hindi or regional language Punjabi also. Annual exams will be conducted for the trainees admitted from the session August, 2023 and their first annual exam has to be conducted in the month of June/July, 2024 after completing the training as per NSQF syllabus of respective trade. Similarly, for two year programs exam has to be conducted in the month of June/July, 2025 after completing the training as per syllabus.

Apart from above CBT and practical examination, regular fortnightly test and other classroom activities will be conducted and performance of the same will be highlighted in the formative assessment chart prepared by the concerned trade instructor and will be taken into account while assigning Final Formative Marks. Improvement in any subject is not available.

- Final CBT fee will be charged as per the guidelines received from DGT, New Delhi during the academic session.
- The failed trainees of all the trades will have to deposit the reappear forms and fees within prescribed time from the declaration of the Result. No forms and fees shall be accepted thereafter.

**National Trade Certificate:** After the declaration of the result by DGT, New Delhi, e-Marksheets and e-NTC are downloadable through NCVT MIS portal and the same are distributed among the passed out trainees at the time of Annual Convocation.

**Apprenticeship Training:** A trainee who passes All India Trade Test under Craftsman Training Scheme is eligible to join the industry as apprenticeship. He/she may contact the Apprenticeship Cell at Govt. ITI, Sector 28-C, Chandigarh for signing the contract as Apprenticeship and further he/she can join the local industry as per vacancy.

**Provision To Appear As Private Candidate:** The Candidate can also appear in the All India Trade Test under Craftsman Training Scheme as a private candidate as per DGT, New Delhi guidelines. The guidelines for private candidates are available at URL <a href="https://ncvtmis.gov.in">https://ncvtmis.gov.in</a>

#### **RULES AND REGULATIONS**

- (i) Each student may enjoy the full benefits of the facilities placed at his disposal but he has to abide by the rules and regulations of the Institute also. These rules are solely designed to safeguard the welfare of Trainees and are liable to change/modify without any prior notice from time to time. The Trainees are advised to keep themselves informed and aware about the day to day instructions and updations in the Institute. A plea of ignorance of any rules cannot be accepted as an excuse of breaking it. Trainees are expected to maintain the decorum and to pay the due respect to all faculty members. Every staff member has authority to point out the indiscipline created by the trainees even of other trades also.
- (ii) Loud talking, loitering or congregating in the corridor, being a source of destruction is not permitted.
- (iii) Late arrival and early departures from the class are recorded as absence from the class.
- (iv) The trainees are advised to work in the workshop as per the instructions of the class incharges.
- (v) No student has any authority over the employees of the Institution.
- (vi) Tools and other machinery must be left in good order after use. If damaged, the fact of the same must be immediately reported for necessary action.
- (vii) No responsibility can be accepted for any loss or damage to student's property.
- (viii) The studies at the Institute require attention and diligence on the part of Trainees. A student neglecting his studies and showing unsatisfactory progress will be given two warnings after which if he/she fails to improve, he/she will be liable for expulsion from the Institution.
- (ix) Trainees shall observe all safety precautions. The Institution is not responsible or accidents of whatever natures in the Institute, Hostel, Workshop and Playground.
- (x) Trainees are issued Smart Card at the time of admission. Loss of the card must be reported immediately and duplicate identity card will be issued on payment of Rs. 50. Failure to inform about the loss will be seriously taken.

- (xvii) Late deposit of fees will be fined @ of Rs. 1/- per day for first 15 days after which the name will be removed from the rolls However, readmission can be granted at the discretion of the Principal with re-admission charges of Rs. 200/-.

#### PROCEDURE TO PREPARE THE MERIT LIST:

- I. U.T. Pool: 85% seats of the total sanctioned intake of the institute will be filled up from amongst the Candidates who pass their qualifying examination from School/College recognized by Chandigarh Administration and situated in the Union Territory, Chandigarh as a regular student of the said School/College. (A certificate from the head of School/College to this effect must be attached). Further the National Institute of Open Schooling (NIOS) Secondary/Senior Secondary pass outs from the accredited schools in UT, Chandigarh shall also be included in the 85% seats.
  - i. 10<sup>th</sup> Class- In case, the total marks secured out of maximum marks are mentioned in the certificate, the same will be verbatim considered for preparing merit list. Otherwise, if total marks secured is not mentioned in the certificate then the total of first five subjects in the detail marks certificates will be considered for preparing merit list for admission in various trades with 10<sup>th</sup> as entry qualification. In other cases, where CGPA has been awarded, the percentage of marks obtained will be calculated by multiplying CGPA by 9.5 (multiplication factor).
  - ii. 8<sup>th</sup> pass- In case, the total marks secured out of maximum marks are mentioned in the certificate, the same will be verbatim considered for preparing merit list. Otherwise, if total marks secured is not mentioned in the certificate then the total of first five subjects in the detail marks certificates will be considered for preparing merit list for admission in various trades with 8<sup>th</sup> as entry qualification. In other cases, where CGPA has been awarded, the percentage of marks obtained will be calculated by multiplying CGPA by 9.5 (multiplication factor). In special cases, where alpha-numeric grades are mentioned against the subjects passed by the candidate, only the grades corresponding to first five subject will be taken into account during calculation of percentage of marks obtained while preparing merit list otherwise if overall alpha numeric grade has been awarded in the certificate then the same will be taken into account for calculating the percentage of marks.
  - iii. In the merit list the order of preference during admission will be firstly the seniority on the basis of **Date of Birth**, secondly obtaining of higher Maths and Science marks/grade points in case of Date of Birth tie and thirdly, obtaining of higher marks/ grade points in English subject in case of dual ties on account of Date of Birth as well as obtaining of higher Maths and Science marks/ grade points.
  - **II. General Pool:** 15% seats will be filled from amongst the Candidates who pass their qualifying examination from the institutions other than those located in the Union Territory, Chandigarh or otherwise. These seats will be termed as "General Pool".
    - a. 10<sup>th</sup>/8<sup>th</sup>: Indicated grand total (marks obtained / total marks) are taken for preparing the merit list. If grand total is not given, then the total of first five subjects in the detail marks certificates will be considered for preparing merit list for admission in various trades with 10<sup>th</sup> or 8<sup>th</sup> as entry qualification. In case CGPA has been awarded then percentage of marks obtained will be calculated by multiplying CGPA by 9.5 (multiplication factor for CBSE board only). In exclusive case of Haryana Board where grand total is not given and GPA is given, then multiplication factor of 10 will be taken into account for considering the merit. In special cases, where alpha-numeric grades are mentioned against the subjects passed by the candidate, only the grades corresponding to first five subject will be taken into account during calculation of percentage of marks obtained while preparing merit list otherwise if overall alpha numeric grade has been awarded in the certificate then the same will be taken into account for calculating the percentage of marks
  - iv. In the merit list the order of preference during admission will be firstly the seniority on the basis of **Date of Birth**, secondly obtaining of higher Maths and Science marks/grade points in case of Date of Birth tie and thirdly, obtaining of higher marks/ grade points in English subject in case of dual ties on account of Date of Birth as well as obtaining of higher Maths and Science marks/ grade points.

Following revision and rationalization of all Craftsmen Training Schemes (CTS) trade syllabus from 1600 annual notional hours to 1200 hours it has been made mandatory for all the trainees to undergo 150 hours of OJT (On the Job Training) at nearby industry wherever not available group project has been made mandatory over and above 1200 annual learning hours

#### **PASS REGULATION**:

The minimum pass percentage for Trade Practical and Formative assessment is 60% and for all other subjects is 33%. There will be no Grace Marks.

#### **ATTENDANCE CRITERIA TO APPEAR IN FINAL AITT EXAMINATIONS:**

It is mandatory for the trainees to maintain 80% attendance in each subject of trade to become eligible for appearing in Final AITT Examinations.

#### **INSTITUTE MANAGING COMMITTEE (IMC):**

The Chandigarh Administration has constituted an Institute Management Committee with a primary objective of increasing the relevance of training and has close Industry Institute interface by participating in the admission, examination, industrial and placement of trainees. The Institute Managing Committee has all powers as per the guidelines received from the Director General Training, Ministry of Skill & Entrepreneurship Development, New Delhi from time to time.

#### 1. BRIEF INTRODUCTORY BACKGROUND

The Government Industrial Training Institute for Women is situated in Sector 11-C, Chandigarh. It was established after the partition of the Punjab as a result of amalgamation of the Zenana Industrial School and Lady Maynard Industrial School for Girls, Lahore. It is the research Institute of trades/crafts in Industrial School for Girls.

The Institute is under the control of the Chandigarh Administration and runs on the pattern laid down by the Director-General of Employment and Training, Government of India. The Director of Technical Education, Union Territory, Chandigarh, is the overall incharge of the institute.

The Institute is headed by Er. Rajan Dogra, as Principal

#### 2. SCOPE AND OBJECTIVES:

The objectives of the institute are linked up with the following activities:-

- (i) To ensure a steady flow of skilled workers in different trades for Industry.
- (ii) To raise the quality and quantity of Industrial production by the systematic training of workers.
- (iii) To create employment opportunities among educated young women by equipping them for suitable Industrial employment.
- (iv) Computer Operator & Programming Assistant will enable the women in acquiring skill and expertise in operating computers. This is helping women in finding jobs in many fields such as Offices, Banks, Publishing Houses, Newspapers etc. or starting their own ventures. Rate of employment is very high.
- (v) Cosmetology trade will enable the women to work in Beauty Parlors/Saloons or open their own Parlors to become self-employed.
- (vi) JOB ORIENTED COURSES: Three <u>highly in demand and highly paid</u> courses viz. Human Resources Executive, Finance Executive and Marketing Executive have been running at this institute.

All the above dues are payable on the spot at the time of admission in CASHLESS MANNER ONLY by using Debit/Credits Cards/Net banking failing which the admission shall not be granted and the same seat shall be offered to the next eligible candidate in the merit list.

Every student will be required to deposit on admission a sum of Rs. 250 as Caution Money. A second deposit may also be asked for, if the first has been exhausted. The Caution Money is refundable to the trainee on the completion of the complete course of one-year duration after deduction of Government dues, if any. Caution Money will be forfeited in the case of trainees who discontinue training after one month of admission.

**Note:** - In case of default in submitting fees and other charges at the time of admission, admission will not be granted.

#### 7. Hostel Facilities

Students desirous to join hostel should apply for the same on the prescribed form. Admission forms for hostel must have photos and signatures of parents and local guardians.

12.5% seats are reserved for Scheduled Caste and 5% for Scheduled Tribes.

#### **Hostel Rules**

- (i) Mess is managed on contract basis on the rate contract duly approved by the Principal and the Hostel Mess Committee at the time of commencement of new session.
- (ii) Each student has to bring health certificate at the time of admission to the hostel.
- (iii) Students must not bring costly Jewellery or keep excessive money with them. No complaint regarding any loss shall be entertained
- (iv) Students are expected to bring with them their bedding, bed linen, books, a tumbler, two plates, a spoon and a tube light.
- (v) The hostel students are not permitted the use of any private electrical appliances, radio etc. In case of default, the electrical appliance will be confiscated from the defaulter to be returned only when she leaves the hostel.
- (vi) The Principal reserves the right of censorship of all correspondence, if felt necessary.
- (vii) Normally no student will be allowed to go out of city except on second Saturday and that too with the permission of Parents/Guardians/Principal and she must reach back hostel in time.
- (viii) Parents/Guardians must write to the Principal for permission before hand in case they want to take their daughters home during the session.
- (ix) Students are required to take meals in the Dining Room in proper dress. No student can bring food to her room.

(vi) The permission for pictures, outings, concerts etc, shall be granted at the discretion of the Hostel Superintendent.

- (vii) No student is allowed to enter hostel during class hours except sickness or has a signed chit from her class teacher or Hostel Superintendent.
- (viii) For the upkeep of the general tidiness, cleanliness, no student shall be allowed to leave the hostel on the last Sunday of the month.
- 2. The Hostel students going out to the Parents/Local Guardians must get a "Pass" before they leave and return this "Pass" back to the Hostel Superintendent on their return duly signed by the Parents/Local Guardians. These signatures will be matched with the signatures on Hostel Admission Forms.
